



## **McJunkin Red Man is Awarded 3-year Integrated Supply Agreement in California**

(NYSE: MRC) announced today that its U.S. subsidiary, McJunkin Red Man Corporation (MRC), has been awarded a three-year integrated supply agreement with the largest combined oil and gas producer in California. This agreement covers all project requirements, maintenance, repair and operations (MRO) supplies and the managing of all materials located at the largest oil and gas warehouse facility in the San Joaquin Basin.
